Instructions for Candidates:

1. Interview will be held through Online mode. Link to appear Online will be shared by e-mail. The Candidate will have to click on the link at the time informed to him for his interview to start.
2. Those who are in employment must submit a “NO OBJECTION CERTIFICATE” from the employers for appearing in the Interview. The NOC should be e-mailed on the e-mail ID: director@aiimspatna.org. The Candidate will not be allowed to appear in the Interview if NOC is not available.
3. Candidates applying under any of the reserved category viz. SC/ST/OBC/PWD will be considered subject to submission of Caste / PWD Certificate on a prescribed format issued by the competent authority recognized by Govt. of India. OBC candidates should not belong to Creamy Layer and should be issued within validity period as per GOI instruction. Their sub-caste should be tallied with the Central List of OBC (non-creamy Layer) failing which their candidature will not be considered under the applied reserved category and will be treated as UR/Gen. Category.



4. Being called for the interview does not essentially declare the eligibility of the candidate for the post. The candidate must ensure that they fulfil eligibility criteria and that the particulars furnished by the applicant are correct in all aspect. If at any stage it is found that the candidate had furnished incorrect information or has suppressed material fact(s) or not fulfilling eligibility criteria as per the advertisement, his/her candidature will stand cancelled. If any of these shortcoming(s) is/are detected even after the appointment, his/her services will be summarily terminated as well as other necessary administrative, financial, and / or legal proceedings will be initiated. In other cases also where anything is detected at any stage of selection or employment, which undermines the eligibility of the candidate on any account; his/her employment is liable for termination.
5. At the time of interview you may be asked to give power point presentation about yourself in slides not exceeding five slides in number.
6. The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
7. Canvassing in any form will be treated as absolute disqualification.
8. During any stage of selection or even after appointment, if the information provided by the candidate viz. including Education, Experience etc. is found to be incorrect his/her selection will be treated as null and void ab initio.

Important Note:

This may be treated as INTIMATION to all eligible and provisionally eligible candidates for scheduled Interview to be held on 22nd May, 2021 as mentioned above. However, Call Letters for Interview has been sent to the eligible and provisionally eligible candidates only.
