TERMS & CONDITIONS:

1. It is candidate's responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. 2. **Tenure:** The assignments are purely on contract basis for a period up to 01 year, which may be extended up to 31st March, 2026 for those whose appointment will be made from staff sectioned by DHR and for a period up to 13.06.2022 extendable upto 31st March 2026 for those whose appointment will be made from staff sanctioned by ICMR. The appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Patna/DHR/ICMR or continued contractual appointment.
3. **Expiry of Contract:** The contract will automatically expire on completion up to 31-03-2026 or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 day's notice or salary in lieu thereof.
