

2. Document relating to registration of firm i.e. GST and relevant document should be submitted along with quotation.
3. Bidder should have registration with Govt. / Semi Govt. organization like railways, State PWD, CPWD, BRO, MES etc.
4. The work shall be executed as per CPWD specification and direction of the Engineer-in-Charge.
5. **PAYMENT TERMS:-**Payment shall be released after the successful completion of the work and receipt of bill after deducting TDS as per Income tax Rules and any other deductions as per Government rules.the entire work shall have to be completed within the stipulated period.
6. Payment shall be made through Electronic Clearing System only and the charges shall be deducted from the bill.
7. Tenderers may please note that they shall follow the safety and security procedures while at work in AIIMS as per the Institute's norms.
8. Tenderers may please note that the work should be executed as per the standard CPWD specification and the measurements shall be recorded as per CPWD specification.
9. The work shall be carried out as per standard specifications of CPWD relevant IS code if the CPWD specification are silent and also as per manufacturers specifications as directed by Engineer-In-Charge.
10. If the contractor fails to maintain the required progress or to complete the work and clear the site on or before the expiry of contract period he shall on account of such breach, pay agreed compensation at ½% of the value of the work per week subject to maximum of 10% of tendered value of work.
11. Work should be completed within 21(Twenty One) days from the date of issue of work order.
12. Performance guarantee @ 3% in the form DD/RTGS/NEFT in the favour of AIIMS Patna shall be submitted by L1 vendor before issuing of work order.
13. 5% security deposit will be withheld and shall be released after completion of warranty D.L.P period.
14. In case the agency is not started the work within 15 days of issue of the work order then the entire amount of Performance guarantee shall be forfeited by AIIMS Patna without any prior notice.
15. 6 months warranty period from the date of virtual completion of the satisfactory installation or good's.
16. Quotation Name/ No. and due date of opening must be mentioned on top of envelopes.
17. AIIMS Patna reserve the right to accept or reject any or all quotations without assigning any reason there of and also does not bind itself to accept the lowest quotation. AIIMS Patna also reserves the rights to accept all the item in the given NIQ or only part of it in any given schedule without assigning any reason.
18. No labour below the age of fourteen year shall be employed on the work.
19. Wages of labour shall be paid as per contract labour regulation and abolition act.
20. Defect liability period will be 6 month after recording at completion certificates.
